

Rules of contest for customers of COMPLEX S.A. "Collect a series of coasters"

1.

The Contest is organized by COMPLEX S.A. with seat in Łódź, Al. Piłsudskiego 143, 92-332 Łódź, registered in the National Court Register kept by the District Court for Łódź - Śródmieście in Łódź, XX Department of the National Court Register under no. 0000256855, NIP: 7282610226, share capital: 51,000,000.00 PLN.

2.

The Contest consists of collecting entire series of 9 pcs of cork coasters for mugs showing parts of CX machines as fast as possible. When arranged in 3x3 composition, the coasters will create an image. In order to win you should collect entire series of coasters, arrange it properly and send a photograph showing properly arranged coasters and 9 codes placed on them to the address contest@cx.pl. The coasters are randomly placed by the Organizer in boxes delivered to customers with goods.

3.

The below prizes will be awarded pursuant to the sequence of emails sent by the Participants to confirm contest solution:

- for the first person that collects the series of coasters: 32" TV-set Samsung LE32B650 in value of 600 EUROS

- for the second person that collects the series of coasters: netbook Asus Eee PC Seashell 1001HA in value of 283 EUROS

- for the third person to collect the series of 9 different coasters: digital camera - Olympus FE-46 in value of 110 EUROS

- for the next ten people who collect a series of coasters: attractive advertising materials of CX.

The Organizer reserves the right to change the prize into another one of comparable value.

4.

Duration of contest: from 19 April 2010 to 30 June 2010 with possibility of prolongation. The Contest Organizer will decide whether the Contest will be prolonged. The Organizer reserves the right to change the date of commencing or ending the Contest.

5.

The Contest is for customers of COMPLEX: companies, manufacturers and personnel servicing machine parts and other power transmission components. Only retail customers may participate in the contest.

6.

The Organizer shall have right to check authenticity of information provided by the Participant, including in particular confirmation that the Participant is a customer or his employee.

7.

Prizes will not be sent by courier mail.

8.

If the value of prizes exceeds 760.00 PLN, the Organizer will collect flat-rate income tax and transfer it to the Tax Office pursuant to the Personal Income Tax Act (Art. 30 clause 1 item 2).

9.

All complaints connected with the Contest shall be notified in writing to the above Organizer's address with detailed grounds, under the pain of expiry of any claims of the given person relating to the Contest within one month from the end of the Contest at the latest. The complaints connected with the Contest shall be resolved by the Organizer within 14 days from submitting of complaint. The Organizer's decision regarding solving the complaint shall be final with no possibility of appeal.

10.

Personal data of the Contest Participants shall be processed for the purpose of conducting the Contest, including selection of the Contest winners, giving out prizes and considering the Participants' complaints. Providing personal data is voluntary. By providing personal data, a Participant agrees to processing the same. The Organizer shall be the controller of the Contest Participants' personal data. The Participants shall be entitled to have access to and to correct the data.

Participating in the contest is equal to accepting the present Regulations.

12.

The Organizer reserves the right to change the Contest rules, including the contents of the present Contest Regulations before it ends.
